

## Notice to Bidders

Sealed bids will be received until 1:00 p.m. on April 22, 2020 by the County Auditor of Otter Tail County for Project Nos. SAP 056-654-006 and CP 20:127B; Full Depth Reclamation, Wear Courses and Topsoil. Mailed bids should be delivered to the County Auditor of Otter Tail County, 510 Fir Avenue West, Fergus Falls, Minnesota 56537. Online bids should be submitted through Otter Tail County's online bidding system (eGram). Hand delivered bids are not allowed at this time.
